Logroño, 26th & 27th February 2020

Business Round – bilateral meetings

The VIII Inward Trade Mission in the Agrofood Sector will join the most important Spanish enterprises in the Food & Wine sector from La Rioja, along with importers and distributors from EU (United Kingdom, Germany, Italy, Belgium, Denmark, Netherlands, Poland, Sweden...), United States, Canada, México and Asian markets (China, Japan and South Korea)

The event consists of:

- Bilateral business meetings previously established in individual agendas, between companies and importers (booking priority to importers)
- Visits to Rioja companies' premises also previously established in individual agendas (according to the selection made by each importer)

The Business Federation of La Rioja (FER) is the promoter of the event, co-organized by Business Organisations from the above mentioned countries. All of them are member of the Enterprise Europe Network (EEN, the Business Network of the European Commission).

Objective

Facilitate bilateral trade between Rioja companies and Importers in the Agrofood sector.

Represented sectors

Enterprises in the Agrofood Sector from one of the most important agrarian and agrofood industrial areas in Spain (Ebro River Valley - La Rioja):

- Wine in Denomination of Origin Rioja, Tinned vegetables (peppers, artichokes, mushrooms, asparagus, etc.), Olive oil, Cold cuts (serrano ham, chorizos, sausages...), Fish & Seafood, Snacks, Sauces, Ready meal, Cheese, etc.

Importers and distributors:

Distributors and importers of the products stated above. Food chains, supermarkets, purchase agents for hotels and restaurants, delicatessen chains of shops and others.

Conditions of participation for importers and distributors:

Free travel and lodging:

Travel costs to Logroño and lodging expenses for three nights will be covered 100% by FER for importers.

- Travel arrangements: Importers must provide a copy of their passport (for flights arrangements) to the contact person from the host organisation (Laura Labanda – laura.internacional@fer.es). Importers must also confirm their travel plan once it has been sent by the host organisation.

16 th to 24 th January:	Importers/Distributors will select the companies they wish to have interviews with (from the local participants), and the ones they would like to visit
From 27 th January:	FER/EEN local point will send the agendas of interviews and visits to importers and distributors (also the travel plan), those will need to be confirmed Importers will receive their flight tickets and hotel reservation by e-mail
